Soccer Season Information

Divisions: Separate Boys and Girls Teams*

Kindergarten: Saturday AM games; 3 on 3; Max of 6-7 per team

1st/2nd: Mon-Fri games 5:30; 7 on 7; Max of 12 per team

3rd/4th: Mon-Fri games 6:30 or 7:30; 9 on 9; Max of 14 per team

5th/6th: Mon-Fri games 5:30 to 7:30; 11 on 11; Max of 16 per team

NOTE: If there are not enough players to fill out separate boys and girls 5th/6th grade teams, then the teams will be coed.

Teams:

All teams will be the same gender and will be determined solely by the administrator. Emphasis will be on balanced teams with regard to grade level. Individual requests will be honored as best as possible. There will be no pre-set teams.

Practices:

Begin Sunday, August 26 at the St. Luke's and St. John's School fields

Coaches:

UCAL is not viable without volunteer coaches. Please consider volunteering to help coach your child's team. The time commitment is two hours per week. There will be a coaches meeting during the first week of practices TBA.

Games:

Begin Monday, September 10 for 1st/2nd and 3rd/4th at St. Luke's

Begin Monday, September 10 for 5th/6th at River Oaks Baptist School

AMATEUR ATHLETIC
WAIVER AND RELEASE OF LIABILITY
AND INDEMNIFICATION AGREEMENT

In consideration of my child, _____, being allowed to participate in any way in the United Church Athletic League (hereinafter "UCAL") and its athletic and sports programs and related events and activities, the undersigned, as parent and/or guardian of the child listed above, acknowledges and agrees as follows:

1. The risk of injury from the sports and athletic activities involved in UCAL and its programs is significant, including the potential for serious injury, including permanent injuries and paralysis, and even death, and while particular rules, equipment, and personal discipline may reduce risk, the risk of serious injury or death does exist.

2. I am the parent and/or legal guardian of _____ and am authorized to enter into this waiver, release and indemnification agreement.

3. On behalf of my child and myself, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, ARISING OUT OF MY CHILD'S PARTICIPATION IN THE ACTIVITIES AND PROGRAMS OF UCAL, EVEN IF ARISING OUT OF THE SOLE NEGLIGENCE OF UCAL, ST. JOHN THE DIVINE, ST. LUKE'S UNITED METHODIST CHURCH, RIVER OAKS BAPTIST CHURCH, ST ANNE'S CATHOLIC CHURCH, OR ANY OF THEIR RESPECTIVE OFFICERS, DIRECTORS, AGENTS, REPRESENTATIVES, EMPLOYEES, COACHES OR OTHER PARTICIPANTS AND ANY PREMISES OWNER, LESSEE OR OPERATOR WHOSE PREMISES ARE UTILIZED FOR ANY LEAGUE ACTIVITY OR EVENT (HEREINAFTER "THE CHURCHES"), OR IF THE NEGLIGENCE OF THOSE SET FORTH HEREIN IS CONCURRENT WITH THAT OF ANY OTHER PARTY AND ASSUME FULL RESPONSIBILITY FOR MY CHILD'S PARTICIPATION THEREIN.

4. I willingly agree to comply with the Rules and Requirements for participation in the activities of UCAL and have had those Rules available for my review. If I observe any hazard during my presence or during my participation or that of my child, I will remove my child or myself, as necessary, from participation and bring any such hazard to the attention of the nearest official immediately.

5. I, for myself, my child, and on behalf of my heirs, assigns, representatives and all successors in interest, HEREBY RELEASE AND HOLD HARMLESS AND AGREE TO INDEMNIFY THE UCAL AND THE CHURCHES, WITH RESPECT TO ANY AND ALL INJURY, DEATH, PROPERTY DAMAGE OR OTHER LOSS OR DAMAGE TO PERSON OR PROPERTY, FOR WHATEVER REASON, REGARDLESS OF WHETHER SUCH OCCURS AS A RESULT OF THE NEGLIGENCE OF UCAL, THE CHURCHES OR ANY OTHER RELEASED OR INDEMNIFIED PARTY, BE IT THE SOLE NEGLIGENCE OF ANY SUCH PARTY OR NEGLIGENCE CONCURRENT WITH THAT OF ANY OTHER PARTY OR ENTITY.

6. I have read this release of liability, indemnification agreement and assumption of risk agreement, understand that I have given up substantial rights by signing it and do sign it freely and voluntarily without any inducement.
